#### 1. Family and Marriage

Professor Dickson Mong'are Nyariki was born on 4 December, 1959 in Mesaria Village, Nyakoora Sub-location, Nyakoora Location, Kegogi Division, Marani Sub-county, Kisii County. He is the  $2^{nd}$  born among six children of Mzee Sebastiano Nyariki and the late Omong'ina Lucia Kerebi Nyariki. Prof. Nyariki is married to Mrs Lydia Gichuku and together they have four grown-up children.

#### 2. Education Background

Prof. Nyariki started his early education in 1966. He attended several primary schools before successfully attempting his Certificate of Primary Education (CPE) at Engoto Primary School in Kisii District in 1975. He was admitted to Kisii High School in Kisii District where he attempted his East African Certificate of Education in 1979 and attained Division I before proceeding to Kagumo High School in Nyeri District, from where he obtained three (3) principal passes in his Kenya Advanced Certificate of Education 1981.

Prof. Nyariki was admitted to the University of Nairobi in 1983 to study Bachelor of Science (Range Management). He completed the studies in 1986. He then proceeded to register for a Master of Science in Agricultural Economics at the same University in 1987, which he successfully completed in 1990. As a result of his thirst for further education, he proceeded to the University of Reading (UK) where he registered for his Doctor of Philosophy (Agricultural Economics) studies in 1994 under a World Bank Scholarship. He completed the course within a record time and was awarded the degree of Doctor of Philosophy in 1997.

## 3. Career Development in the University Sector and Public Service

Prof. Nyariki has held numerous senior administrative positions in various universities in Kenya and in the Public Service. For instance, upon his graduation from the University of Nairobi in 1986, he served in the Public Service as a District Range Planning Officer in Isiolo District, from 1986 to 1987. In 1989, while pursuing his M.Sc. studies at the University of Nairobi, he was recruited as a Graduate Assistant, Department of Range Management, for a period of 2 years. Following his graduation with a Masters in Agricultural Economics in 1991, he was

appointed as a lecturer in the same department. In 1999, he was promoted to the position of Senior Lecturer, Department of Range Management, and appointed the Chairman of the department. As Chairman, he spearheaded the negotiation for and implementation of the following research projects: the Regional Climate Prediction and Application for the Greater Horn of Africa Project (USAIDfunded); livestock production Systems in the Greater Kibwezi and tenure systems and food security in pastoral areas (Sida-funded); ROSELT - dealing with dryland development including water development in collaboration with the Ministry of Water Development (Germany (GTZ)-funded); POPS - dealing with many aspects of desert combat and poverty alleviation through livelihood improvement (EUfunded); execution of the Pastoral Information Network Programme (PINEP). PINEP was involved in training range management specialists for IGAD countries, that is Kenya, Uganda, Ethiopia, Sudan, Eritrea and Djibouti, and Tanzania at both M.Sc. and Ph.D. levels. PINEP was also involved in disseminating pastoral information through publications of research outcomes coordination and execution at the national level of the Dryland Husbandry Project (DHP) which was regionally coordinated by the Organisation for Social Science Research in Eastern and Southern Africa (OSSREA) whose headquarters was Addis Ababa, Ethiopia. The project involved Kenya, Uganda, Ethiopia and Sudan (Sida-funded). Because of Prof. Nvariki's exemplary performance, OSSREA bestowed on him a Distinguished Service Award.

Further, while working as Chairman of department, Prof. Nyariki was promoted in 2004 to the position of Associate Professor, Department of Land Resource Management and Agricultural Technology. In 2010, he was appointed by the South Eastern University College - SEUCO - (a Constituent College of the University of Nairobi) as Deputy Principal (Administration and Finance). During the time he was serving as Deputy Principal, he was competitively appointed to the position of full Professor of Agricultural Economics in 2013. SEUCO was soon after upgraded to South Eastern Kenya University (SEKU), and he was Deputy Vice Chancellor (Administration and Human Resource Management). In March 2016, he moved from SEKU to Murang'a University College (Constituent College of Jomo Kenyatta University of Agriculture and Technology) as a Principal. In October 2016, when Murang'a University College (MRUC) was upgraded to a University and re-named Murang'a University of Technology (MUT), he was appointed as the Ag. Vice Chancellor until February, 2018 when he was confirmed as the Vice Chancellor of Murang'a University of Technology.

Prof. Nyariki also served as Chairman of the Thematic Working Group (TWG) for food security of the Agricultural Sector Coordination Unit (ASCU), Government of Kenya.

#### 4. Distinguished participation in Research Activities and Consultancy

Prof. Nyariki has engaged in numerous research and consultancy services both locally and internationally for more than twenty five years. **5. Publications, Supervision of Postgraduate Students and Journal Refereeing** Prof. Nyariki is an accomplished scholar. In addition to teaching at B.Sc., M.Sc. and Ph.D. levels for many years, he has supervised close to 40 M.Sc. and Ph.D. students, and published more than100 journal articles, books, book chapters, and peer reviewed proceedings and reports. He has also refereed for several journals including the *East African Agricultural and Forestry Journal, Discovery and Innovation*, and *Journal of Developing Areas.* 

#### 6. International Engagements

Prof. Nyariki has served in various capacities internationally. For example, he served as the Sub-Regional Coordinator for the FAO Initiative on Soaring Food Prices (ISFP) based in Addis Ababa, Ethiopia between 2009 and 2010. The aim of the initiative was to address the problem of soaring food prices by improving the availability of farm inputs to enhance food security through increased grain production, involving six countries - Kenya, Ethiopia, Sudan, Djibouti, Burundi, and Rwanda. He also served as a Regional Coordinator for Water Harvesting Pilot Project in the IGAD Region between 2005 and 2008. The project's main objective was to improve water availability for enhancing food security through increased livestock and crop production, involving four countries - Kenya, Uganda, Ethiopia, and Sudan.

#### 7. Professional Associations

Prof. Nyariki is a member of various professional organisations in Kenya, Africa and the UK. Some of these organisations are the African Association of Agricultural Economists (AAAE), Kenya Institute of Management (KIM), and British Agricultural Economics Society (AES).
